Most Recent Court Action, and More!

In the last “Gary Report” I noted that the teaching sessions when we were in Africa “clearly came with trouble and concern for our own lives. In fact, two men were jailed because of their attempts to kill us. But we survived, and now await the fulfilling third part in this trinity, which I will now address.” Those two men were Erick Ojwang and Calvince Okoth Amayo, addressed in the December 10, 2018 Report. Erick is actually a relative to the Calvins in Rongo who caused so much trouble to Caleb and the Bride (November 2, 2018 Report). Well, those two men got out of jail on bail and continued to plot our harm. In this effort, they even filed for the arrest of Caleb, Walter, and myself just before Jim and I were to fly back to the U.S. Our attorney, Tom Mwaboza, warned us that if this was not countered, they could possibly arrest me at the airport; so we provided for him to counter this.

This group continued to cause great harm, thus Tom also filed legal action against both of these men, as well as three others: Domnick Kimani, Fred Ochieng, and Ben Kizito. These men are the ones who came over to our apartment with three others after the teaching in the slum, and Caleb, Walter, and Jacob passionately sent them all away. These pastors are evil men, whose head is Satan, and we received news the day before the trial that Tom’s wife and father were both shot and killed. At the trial, Tom also spoke of these deaths; and with all of the evidence at hand, each of the five men were sentenced to six years in jail. And this decision was now in the high court and cannot be overturned, except in rare occasions by the President of Kenya in the Supreme Court. Nor can they pay bail. They will be in to stay!

And if this wasn’t bad enough for our faithful brother, later in the day Tom learned that two of his six children disappeared, obviously taken by the same enemies. These are seven-year-old Julius and five-year-old Marry. Please pray for these precious innocent children. The other four children are going to have to be hidden away now, along with Tom. And here is his conclusion he shared with me in an email: “I did not know that my life would one day be so complicated like this, but am not regretting joining the Bride, the only true faith and belief that can make Emmanuel come back. I am a Bride.” Please help make possible the provision for this brother financially, as well as for meeting other like pressing needs at this time. He is removing himself from the public to sort out what is next.

Oh, and by the way, on a positive note we have been issued our Society registration that gives us legal standing to conduct the Remnant Bride Church in all of Kenya. In fact our enemies said we did not yet have it, but now we do. They are so desperately, desperately wrong! When will they learn? Grant us victory, oh Father, over our enemies! And I ask you to be a part of that victory by your much-needed financial support right now. Tom has paid the highest price, and I need for you to do your part as well.
