## **GARY REPORT**

## **Identification/Intercession That Leads To Victory**

If you have not read the June 17 Report titled "Get To The Root," you need to do so first. From it you will recall that seven men were captured for the attempted murder of Lawrance and the theft of the Bride's car. Of course two men were attempting to enter into Rwanda with it, but upon failure to prove ownership, one man tried to flee and was shot and killed, and the other man remained and was taken into custody. The authorities found out the car was stolen, and Caleb went to reclaim it. I have talked with Lawrance, and let me tell you more of the story.

Lawrance was driving the car at night (which is dangerous and should have been avoided) to go meet up with the other men, and saw some tree trunks and limbs on the road, blocking access. He thought a tree fell, and stopped to remove it. Of course it was not such, and two men with a gun and machetes captured him. From there they drove to Busia, and then attacked Lawrance with the machetes to kill him and left him for dead. But he was found and transported to the hospital in Bungoma where he was placed in ICU and treated. You know the rest of the story regarding him and the car, and both were restored, though at quite a cost.

And you know that from the testimony given by the one who was captured, a total of seven men were implicated in this and all seven were arrested. Then on Monday, June 18, Caleb, Constable Rubben, and Lawrance traveled to Busia for the trial, which took place before a judge. Later, Rubben told me that he did not want to let me know the outcome, because the judge dismissed all of the charges. Rubben suspected that the judge might have been bribed. However, he did not leave the outcome with this decision, and filed an emergency appeal with the High Court in Busia, which in fact met the next day to consider this. That court is composed of three judges, and at that session the ruling of the lower court was overturned and all seven men were found guilty. They were charged with robbery with violence—which Rubben said in Kenya can carry the death penalty—as well as the illegal holding of a firearm. And he said that the judges were actually lenient in giving them each 23 years of jail time!

I have already noted in the last report that this entire matter is strikingly prophetic. Seven men associated with the Busia violence were judged just last April, and now we find seven more men being judged from the same source in Busia. And in the words of Constable Rubben, "Evil was defeated!"

Also as noted in the last report, one of the amazing things that Yahweh did in this was to have someone who was in a place of authority so as to help in our time of need and deliverance. You will recall the following: "And most amazing, one of the officers from Rwanda effecting those arrests [of the first seven], was none other than one of the men present in that beginning meeting in Busia where I taught. His name is Benjamin, and I had the honor of speaking with him on the phone while they were in Busia, delivering the man who was in the car at the Rwanda border and capturing the seventh man.

There is great evidence that all of this has come full circle, and we are seeing the hand of Yahweh in it." And that circle just added a second witness.

I just noted that Rubben filed an emergency appeal with the High Court that met that next day, and that that court is composed of three judges. It was there that we received the fair and just ruling of the guilt of those seven men. Later that day I actually spoke with one of those judges, Richard Yanke. And to my surprise and wonder, he had also attended that Busia meeting where I taught. Again, full circle. And not only did he attend that meeting, but he had traveled up to Bungoma when I taught there, and had even traveled down to Rongo when I taught the largest meeting at that time. Judge Yanke was fully aware of what these teachings meant, and fully supported them. It is truly amazing to see what the Father has done, and we look to Him to give further evidence and favor to the Bride for the furtherance of this truly vital truth for all mankind. Blessed be Yahweh!

Now for our conclusion to this remarkable account and experience. It is actually quite hopeful that the three High Court judges chose to sentence each of the seven men to 23 years in jail. Why? Because in my own life 23 years in "jail" are in fact the price I have been paying since 1994—including the loss of my family—while waiting for the complete fulfillment of the Bride. In reality, even the Bride truth has been in prison for 23 years; and just as those men would be set free at the end of their sentences, I trust I will be set free at this time with the end of my own 23 years. Of course this is actually 23 years, 23 years, and 23 years for me, and on August 7 of this year I will be 70 years of age. The people of Jerusalem who had been captured by the Babylonians, were as well set free from their bondage at the 70th year as well—set free to restore and rebuild the temple. And this is the spiritual temple that has to be rebuilt today. So, these seven men are undoubtedly not only prophesying, but also spiritually witnessing to or even paying a like price. And of course we are now in the seventh 1,000-year period of man, the Sabbath rest. As you can see, it was Yahweh's Divine order that the judgment of the seven was set at 23 years.

But in addition, evil has to be turned into good. That is Yahweh's plans and ways. If He did not have mercy and perform the work that man has failed to perform for two and even six thousand years, this seventh day would be the end and destruction of mankind! It would be, "My God, my God, why have you forsaken us?" But He will perform this redeeming work, even as it is written, "The things that are impossible with man, are possible with God" (Luke 18:27). Thus, it is quite interesting that the Bride brothers who are journeying out to teach and to strengthen what has already begun are now united, and with the second car now available will divide into two traveling groups—three in the Bride car, and four in Morasi's car. Did you notice that? Three and four is seven. What has been evil in the hands of our enemy/enemies, is turned to good and success. This is what Yahweh has to do for all mankind.

These brothers have now become a split work, and splitting something <u>makes it clean</u>. Also, you will recognize the breach pattern that the brothers entered into. Lawrance began his journey at night, and his journey was taken over by evil (which happened to the church as soon as Yahshua left). His journey then breached and his life was at the threshold of death. The enemy took over the Bride car and possessed it (just as Satan took over the kingdom and possessed it). And in their hands, they almost destroyed it

(again, relative to the kingdom). But their actions were exposed and justice prevailed and the enemy judged (by an overturning three-part High Court) and the car restored and the great and terrible breach was healed! THAT is where I hope and trust we are at today in the Bride, even in the church, and that Satan has been judged.

And on this side of this breach, may we the Bride be made clean by being a split work. And it is amazing that God the Father has artfully effected this intercession, this identification, as revealed here, so that we can now hopefully enter into His great fulfillment—the calling out and establishment of the Bride, her catching up to be with her Husband, and thereupon to rule and reign with Him on this earth. And for me, it will be the end and healing of my own third-part 23-year breach, for which I will GREATLY rejoice! All of this, my friend, is Yahweh's effectual identification or intercession. May He be praised! He alone is worthy. Amen.
